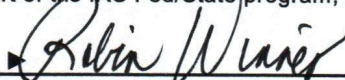

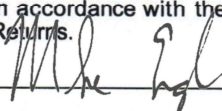

WE ALSO WERE GRATEFUL THAT WITH COMMUNITY AND GOVERNMENTAL SUPPORT, WE DID NOT HAVE TO REDUCE OUR WORKFORCE OR FURLOUGH ANY EMPLOYEES. WE ALSO RAISED FUNDS TO INTRODUCE AN AGENCY-WIDE TESTING AND TRACING PROGRAM THROUGH OUR CHILDREN'S MERCY HOSPITAL ONSITE CLINIC THAT KEPT OUR CLIENTS, STAFF AND FAMILIES SAFE BY PROVIDING RAPID RESPONSE ONSITE TESTING, THEREBY REDUCING SERIOUS OUTBREAKS AND THE NEED FOR EXTENDED QUARANTINES. OVER THE PAST MONTHS, WE HAVE DEVELOPED A THREE-TIER MODEL IN WHICH THE USE OF SHELTER IS OFTEN AN INTRODUCTORY SHORT-TERM SOLUTION, THE USE OF INDIVIDUAL HOTEL SPACE WITH WRAP AROUND MENTAL HEALTH AND CASE MANAGEMENT SERVICES AN INTERMEDIARY SOLUTION, AND THE RELOCATION OF SURVIVORS INTO THEIR OWN LONG-TERM HOUSING THE BEST SOLUTION FOR MANY DOMESTIC VIOLENCE SURVIVORS AND THEIR CHILDREN.
